Self-Certification of Rule Amendment Under § 40.6(a): Compliance-Manual Revision

Dear Secretary Kirkpatrick:

RTX Fintech & Research LLC (RTX SEF) intends to implement a change to its compliance manual under 17 CFR § 40.6(a) on March 21, 2024. This compliance manual replaces the compliance manual that RTX SEF implemented on May 1, 2023, which was substantively the same as the one that RTX SEF submitted (on March 20, 2023) as Exhibit O to its SEF application; the changes from the March 20, 2023 version to the May 1, 2023 one were that RTX SEF slightly modified the formatting and added information to the "Document Control Page."

Attachment A contains the amended compliance manual; Attachment B, a redline of the amended compliance manual against the May 1, 2023 version; and Attachment C, a redline of the May 1, 2023 version against the March 20, 2023 version.

Below is the concise explanation and analysis that the Commission requires under 40.6(a)(7)(v). This amendment relates to certain conditions under which RTX SEF will provide notice to the Commission about changes to its ownership that may pose potential conflicts of interest, and it contains certain non-substantive changes (e.g., an update to RTX SEF's address). Its purpose is to ensure that the Commission has timely notice of those potential conflicts of interest. In operation, it will ensure that the RTX SEF provides the Commission notice of the potential conflicts of interest.

The amended compliance manual complies with both the Commodity Exchange Act (Act) and Commission's regulations. Specifically, it complies with Core Principle 12 (Conflicts of Interest) because it functions as an additional control on potential conflicts of interest.

No one has expressed any substantive opposing views to the rule amendment that RTX SEF has not incorporated into the rule.

Finally, on behalf of RTX SEF, I certify the following:

- 1. RTX SEF has posted on its website a notice of pending certification with the Commission and a copy of this submission (redacted).
- 2. The amended rule complies with the Act and the Commission's regulations.
